

Religious Liberty for All

Agudath Israel of America v. Cuomo, Diocese of Brooklyn v. Cuomo

- In a midnight order on Thanksgiving eve, SCOTUS handed down a significant win for houses of worship, stating that “even in a pandemic, the Constitution cannot be put away and forgotten. The restrictions at issue here, by effectively barring many from attending religious services, strike at the very heart of the First Amendment’s guarantee of religious liberty.”
- Becket and Troutman Pepper filed an emergency application on behalf of Agudath Israel, a 98-year old Jewish advocacy group. The Diocese of Brooklyn also filed a separate application.
- The Court stated that Gov. Cuomo’s “regulations ... single out houses of worship for especially harsh treatment,” allowing “businesses categorized as “essential” [to] admit as many people as they wish” while synagogues and churches are limited to 10 or 25 people.
- There are more cases in the pipeline at SCOTUS, starting with two petitions currently with Justice Kavanaugh arising from Kentucky, one of which is led by Kentucky AG Daniel Cameron.

Fulton v. City of Philadelphia

- Two foster mothers, Sharonell Fulton and Toni Simms-Busch, asked SCOTUS to protect their freedom to partner with a Catholic ministry to care for foster children in need.
- Over thirty *amicus* briefs were filed in support of faith-affirming foster care, including two briefs from 16 different states ([one brief](#) led by the Attorney General of Texas, [the other](#) led by the Attorney General of Nebraska).
- At [oral argument](#), the Justices were wrestling with the harm of Philly's discrimination, concerned that city officials were manufacturing an unnecessary fight. Justice Kagan worried about the City's double standards, and Justice Kavanaugh called the City's position "absolutist and extreme," noting that Philadelphia "created this clash."
- In response to questioning, the ACLU's attorneys acknowledged their arguments could allow government officials to take over religious hospitals and then force them to perform abortions.
- The Justices also focused much of their questioning on the future of *Employment Division v. Smith*.

Little Sisters of the Poor v. Commonwealth of Pennsylvania and California v. Little Sisters of the Poor

- Despite a 2016 victory at the SCOTUS and a new rule that protects the Little Sisters of the Poor from the HHS mandate, the Little Sisters are still in court.
- The problem now is that the Attorneys General of PA and CA, joined by several other states, sued in federal court to take away the nuns' hard-won religious exemption.
- Twenty states, led by the Attorney General of Texas, filed an [amicus brief](#) in support of the Little Sisters.
- On July 8, 2020 the Supreme Court [ruled in favor](#) of the Little Sisters of the Poor in the Pennsylvania litigation and shortly thereafter [GVRd](#) the California litigation. A hearing on the California case is scheduled for December 16.

Our Lady of Guadalupe School v. Morrissey-Beru

- This was the first Supreme Court case since *Hosanna-Tabor Evangelical Lutheran Church and School v. EEOC* to consider the boundaries of the ministerial exception.
- The Ninth Circuit ruled that religious teachers at Catholic schools, even teachers with many religious duties, were not religious enough to warrant First Amendment protections.
- Seventeen states, led by the Attorney General of Alaska, filed an [amicus brief](#) in support of the school.
- On July 8, 2020 the Supreme Court [ruled](#) 7-2 in favor of Our Lady, finding that the government cannot control a church school's decision about who teaches its religion classes.

Espinoza v. Montana Department of Revenue

- The Montana Department of Revenue refused to implement a tax credit program for scholarship contributions, citing the state's Blaine Amendment.
- Becket filed a friend-of-the-court brief arguing that the discriminatory history of the Blaine Amendments renders them unconstitutional, and that religious organizations cannot be treated as second-class citizens when it comes to widely available public benefit programs.
- Eighteen states, led by the Attorney General of Georgia, filed an [*amicus* brief](#) in support of the students. The brief was cited in Justice Alito's concurrence.
- On June 30, 2020, the Supreme Court [decided](#) that children in Montana cannot be stripped of their right to participate in a scholarship program simply because they attend religious schools.



Additional Cases

- [NY v. HHS](#)
 - After HHS released a rule enforcing existing laws protecting religious healthcare professionals, several states (led by New York) sued to block the rule.
 - Becket is representing Dr. Regina Frost, an OB-GYN, and the Christian Medical & Dental Associations, arguing that no healthcare professional should be forced to choose between violating her conscience or providing compassionate medical care.
 - Sixteen states, led by the Attorney General of Ohio, submitted an [amicus brief](#).
- [IVCF v. University of Iowa](#)
 - Becket is representing the InterVarsity Graduate Christian Fellowship student group at the University of Iowa who was effectively kicked off campus for encouraging its student leaders to share its faith.
 - In 2019, a district court found that the University had violated the First Amendment. The University appealed to the Eighth Circuit, and the case is now awaiting oral argument.
 - Fifteen states, led by the Attorney General of Nebraska, filed an [amicus brief](#).
- [Payne-Elliott v. Archdiocese of Indianapolis](#)
 - After a Catholic high school teacher in Indianapolis violated his agreement with the school by entering a same-sex civil union, the Archdiocese informed the school that it could not continue employing teachers who lived in defiance of Church teaching.
 - The teacher sued the Archdiocese in state court, arguing that the Archdiocese illegally interfered with his agreement. This case is currently at the Marion Superior Court of Indiana.
 - The [State of Indiana](#) and the [Department of Justice](#) filed *amicus* briefs.
